

CRZ clearance may be granted subject to the following conditions:

(a) General

- (i) The construction of the structures, if any, may be undertaken as per the plans approved by the concerned local authorities, in conformity with the existing local and central rules and regulations including the provisions of CRZ notification.
- (ii) All safety norms would be ensured and proper arrangements may be made for providing fire extinguishers and other equipments as per the relevant regulations/guidelines of the state/central authorities.

(b) Specific to CRZ

- (iii) No activity which is prohibited by the CRZ Act (1991) and its subsequent amendments may be taken up in the CRZ area including setting up of ice plants.
- (iv) The HTL and LTL delineated in the CRZ status report should be followed and no development activities are permitted in the CRZ area as demarcated in the status report.
- (v) The project proponent must take necessary arrangements for disposal of solid wastes and for the treatment of effluents/wastes. It must be ensured that the effluents/solid wastes are not discharged into the rivers/backwaters/sea.
- (vi) The project proponent should sent an annual report of the project every year to this Authority.



(vii) The project proponent should provide necessary facilities for the officials of CZMA for inspection of the project site and it premises at any time.


Representation submitted by one Mr.A.K.Khaiid and K.K.Shihab from Chavakkad informed that a construction (burial ground) is proposed to be undertaken by the Chavakkad Municipality on the Manathaia beach in between High Tide Line and Low Tide Line. The Additional Director, Ministry of Environment and Forests, Government of India vide his letter dated 20 (2006 has requested to get the matter examined and to send the report to Ministry of Environment and Forests. In this regard, Local Self Government Department was requested to furnish their remarks to this department vide U.O.No 24.11 06. Reply is being awaited.

Point for decision

Whether the Local Self Government. Department may be requested to direct the Chavakkad Municipality to enquire and take necessary action in the case

Hotel Seaface, NUP Beach Road, Kovalam unauthorized construction Stay Order - reg.

Hotel Sea face, Kovalam filed WP©No.21527/2006—against the unauthorized construction in the CRZ area in Vizhinjam. The action against unauthorized construction was stayed by the Court on 14.8.06 on condition that petitioner shall not undertake any further construction.



Site inspection was conducted and it was found that, no construction is being carried out at present. The construction was carried out after 1991 and it is built within 200m from HTL in CRZ III area. This is violation of the provisions in CRZ notification 1991. Copy of the Site Inspection report is attached as Annexure II.

Point for decision

For advice of the next course of action to be taken in the above OP's.





Tsunami Emergency Assistance Project – CWSS for Tsunami affected areas of Karunagappally, Alappad, Arattupuzha, Clappana, etc.

Project Director, Kerala Water Authority has submitted the proposal for comprehensive Water Supply Scheme in the Tsunami affected areas of Kollam, Alappuzha Districts. The project is being implemented with the assistance of ADB under TAEP. The proposed construction lies in the CRZ area. Construction for water supply is a permissible activity. Clearance may be given subject to the following conditions:

- 1. The construction of the structures, if any, may be under taken as per the plan approved by the concerned local authorities, in confirmation with the existing local and central rules and regulations including the provisions of CRZ notification.
- 2. No construction shall be made in CRZ I(i) area.

Whether permission may be granted for the proposed scheme.

Resort Project in Perumbalam Island - P.R.Holiday Homes Pvt. Ltd.

New proposal for consideration

Construction of building for Research Institute and Avurveda Hospital



Chairman, Somatheeram Research, Institute and Ayurveda Hospital Pvt. Ltd. Submitted the proposal for construction of Ayurveda Hospital in Kottukal Grama Panchayat, in the CRZ area between 200M and 500 M.

Development of vacant plots between 200M and 500M of High Tide Line in designated areas of CRZ III with prior approval of Ministry of Environment and Forests permitted for construction of hotels/beach resorts for temporary occupation of tourists/ visitors. The height of the building shall not exceed 9 metres and the construction shall not be more than 2 floors. The proposed building is a 3 storeyed one, with 10.51M height, this is not permissible. From the documents, it is not clear that the construction is within No Development Zone as the status report produced dates back to 6.4.1998. The construction points are not mentioned in this report.

CRZ Clearance for residential building in Kollam Municipality - reg.

The KCZMA noted that the proposed construction lies landward side of the imaginary line joining the two existing close by buildings which lies in CRZ II. As per CRZ notification, construction on the landward side of the building existing prior to 1991 is permitted. Hence, construction of the above residential building is permitted subject to the following conditions:

- (i) The buildings MC No.1165/635-A,KC/X/1060 and MC.No.V/687 K.C/X/980 were constructed prior to 19th February 1991.
- The design and construction of proposed building shall be consistent with the surrounding landscape and local architectural style.
- [iii] Effluents or cutlet of the septic tank should not be discharged into the river.
- (iv) Payment of scrutiny fee depends on the estimate of the project.

The Secretary, LSGD may be informed accordingly.

CRZ violations in Vizhinjam Gramapanchayat - W.P.252/06 - reg.

The KCZMA noted the report submitted by the Vizhinjam Gramapanchayat Secretary in his letter dated 31.10.2006 informing that numbers of buildings constructed by Shri. Sreekumar IX/1300 VP, 1301 VP,

CRZ Clearance for Coir Industrial Building - reg.

ECZMA decided to inform the Secretary of Payyannur Municipality that the proposed site falls in CRZ II. Since the proposed building is for industrial purposes, it is a prohibited activity in CRZ, i.e., area which lies at a distance equal to the width of the river or 100m from the High Tide Line of the river, whichever may be less. Hence the proposal is rejected.

ORZ Clearance for reconstruction of residential building - reg.

The proposal for reconstruction of an old residential building proposal submitted by the Secretary, Pappinissery Gramapanchayat was approved by the KCZMA as it was stated to be more than 80 years old with less plinth area for the proposed reconstruction building in comparison to the existing building. As per CRZ notification, reconstruction/alteration of an existing building is permitted without increase in plinth area and subject to the following conditions:

- (i) Over all height of the construction should not be more than 9m and construction shall not be more than two floors.
- (ii) The mangroves, if any, in the vicinity should not be disturbed.
- (iii) The waste generated during construction should not be dumped in CRZ area.
- (iv) The effluents/outlet of septic tank should not be discharged into the river.



ANNEXURE -II

Field Inspection Report

A field inspection was carried out at Kovalam as directed by Hon'ble High Court in WP(C)5825/2007 on 26.3.2007 by Shri.Jocose Panicker, Section Officer, Science and Technology Department and Shri.Harinarayanan, Scientific Officer, KSCSTE.

The area as referred in writ petition was verified and identified with the help of Vizhinjam Village Officer. As per the records it is noted that Sy.No.30/1-2 is owned by Smt.Remasree S.Kumar, W/o.Shri,G.Sudhish Kumar(2nd Respondent). Sy.No.30/2 is owned by Shri.Ajith Kumar, S/o.Sri.Sreevardhnan, Sreesarasil, Ayamkode, Thoyichal Desam, Venganoor Village and Sy.No.29/10-11-12 is owned by Smt.Meenashi Nagamma., Mother of Smt.Remasree.S.Kumar. A Hotel named Seaface is seen constructed in the said area and it lies within 200m from High Tide Line of Sea in CRZ III.

It is observed that the construction was made after 1991 and they were not able to provide other details regarding the construction of hotel, building number, etc. As per the available information on local enquiry it was built during 1995. As per CRZ notification dated 19th February, 1991 Development of vacant plots between 200 and 500 meters of High Tide Line in designated areas of CRZ III with prior approval of Ministry of Environment and Forests is permitted for construction of Hotels/Beach resorts for temporary Occupation of tourists/visitors subject to conditions stipulated in the guidelines.

The 2nd Respondent was also requested to produce all documents regarding the year of construction, building numbers, etc. and till date (17th April, 2007) he has not produced any documents. As no documents are produced based on the available information it is concluded that the construction was carried out after 1991. This hotel being built within 200 meter from HTL in CRZ III area after 19th February, 1991 thus violates the provisions of CRZ notification 1991.

No fresh construction is seen undertaken in the site during inspection, now as noted in the judgment.

Report of the Sub-Committee Constituted by the Kerala State Coastal Zone Management Authority (KCZMA) for the Proposed Resort by M/s P.R. Holiday Homes Pvt. Ltd. at Perumbalam Island.

The Kerala Coastal Zone Management Authority has constituted a Sub-Committee for site verification for the resort project proposal submitted by M/s P.R. Holiday Homes Pvt. Ltd. at Perumbalam Island vide order No. 207/ENV/06/CZMA, dated: 06.02.2007. The Sub-Committee consists of the following members:

- 1. Dr. N.R. Menon
- 2. Dr. M. Baba
- 3. Dr. Madhusoodana Kurup
- 4. Dr. Kamalakshan Kokkal

The Sub-Committee except Dr. M. Baba, Director, Centre for Earth Science Studies visited the site on 9th March 2007. The proposed site for the resort is located at Perumbalam Panchayath in Alappuzha District. Perumbalam is an island in the Vembanad Kayal and is connected to the main land only by ferry service. The proposed development site has the Vembanad backwater on its north, east and west sides. In the case of backwater banks, resort development is subject to the CRZ regulations which stipulate 100m line as No Development Zone and construction is permissible landward of the 100m or the appropriate regulation zone of the area. There are well built embankment on the bank of the backwater bordering the proposed development site. The height of the embankments is more than the maximum tidal range of one meter, usual tidal amplitude felt within the region of the backwater. Since there is a sheer drop of 2m at the embankment there is no tidal flats and practically no land is exposed during the low tide. The project site is located in an area that is less developed and does not belong to CRZ –I. The area is devoid of any mangrove vegetation or ecosystem categories to be grouped under CRZ-I in the project area. There are quite a few yielding cashew trees and numerous well yielding coconut palms. The Sub-Committee is of the opinion that

clearance for the proposed project may be issued by KCZMA as the project lies landward of 100m No Development Zone from HTL of the backwater subject to the following conditions:

a) General

- i) No construction should be made within the No Development Zone as demarcated in the CRZ status report.
- ii) Effluents and sewage should not be discharged into kayal/backwater.
- The construction of the structures, if any, may be undertaken as per the plans approved by the concerned local authorities, in conformity with the existing local and central rules and regulations including the provisions of CRZ notification.
- ii) All safety norms would be ensured and proper arrangements may be made for providing fire extinguishers and other equipments as per the relevant regulations/guidelines of the state/central authorities.

b) Specific to CRZ

- No activity which is prohibited by the CRZ notification (1991) and its subsequent amendments may be taken up in the CRZ area.
- iv) The project proponent must take necessary arrangements for disposal of solid wastes and for the treatment of effluents/wastes. It must be ensured that the effluents/solid wastes are not discharged into the rivers/backwaters/sea.
- v) Division of backwater into the project site by canals, if any, is not permissible.

The Sub-Committee, hereby, agreed to the above report for submitting to Chairman, KCZMA.
