Agenda Item No.3

New Proposals for consideration

Construction of resort in Ramanattukara Grama Panchayat- Application of Sri. Water Aravindakshan white Line Hotels Ltd.

The Secretary, Ramanattukara Grama panchayat has forwarded the proposal for the construction of a resort in Re-Survey No 2/1, 2/2A,3/1, 3/5, 9/4, 9/5, 10, 11/1,11/2,12/1 in ward No 1, in Ramanattukara Grama Panchayat, Kozhikode District. The environment group of the KSCSTE has opined as follows:

"The CESS has prepared the CRZ map of the proposed site in 1:4000 scale. As per the map, the proposed constructions are lying outside CRZ area, though part of project area falls in No Development Zone of CRZ III. Construction of resort can be placed in KCZMA for recommending to MoEF, for EIA clearance as the total plinth area is more than 20000m2. Following conditions need to be considered for providing the CRZ clearance/recommendations to MoEF.

- a) The Project proponent shall undertake proposed constructions only beyond the hazard line or 100m from HTL whichever is more.
- b) The project proponent shall not make any constructions within 100m from HTL.
- c) No permanent structure for sports facilities except goal posts net posts and can post will be permitted.
- d) Ground water shall not be tapped using mechanical means from CRZ area.
- e) Extraction of sand, leveling or digging shall not be made in NDZ of CRZ III.
- The quality of effluents, solid waste, emissions and noise level and the like from the project area must conform to the standards laid down by the competent authorities including the Central or State PCB and EP Act 1986.

- g) Necessary arrangement shall be made for the treatment of the effluents and solid waste and it must be ensure that the untreated effluents and solid waste are not to be discharged into the river and
- h) Necessary approval of State Tourism Department needs to the obtained.

 As the site plan shows that water body is to be created in the NDZ, digging being a prohibited activity it cannot be permitted in CRZ area."

POINT FOR DECISION

Whether the proposal may be forwarded to Ministry of Environment and Forest subject to the conditions.

CRZ clearance sought by the Secretary, Thekkumbhagom Grama panchayat for 2 houses in the area

The Secretary, Thekkumbhagom Grama Panchayat has sought CRZ clearance for two houses to be constructed by Sri. Francis Xavier and Shri.Dominique under a Government aided housing scheme. The matter was placed before the KCZMA meeting held on 09.05.2011. KCZMA decided to defer the case for consideration, after getting a detailed field assessment report. Inspection report has been furnished by the environment group

In the first case, construction by Shri. Francis Xavier is s proposed in a site which lies 41m from HTL of Astamudi Kayal in Thekkumbhagom Grama panchayath, which is an island according to CESS. As per available information and KCZMP, the site lies in the NDZ of CRZ III. In the Second case, the site proposed by Shri. Dominic, lies 9m from HTL of backwater. The site lies in the NDZ of CRZ III.

POINT FOR DECISION

Whether CRZ clearance may be given to two houses which, are to be constructed under Government aided housing scheme.

CRZ clearance sought by the Secretary, Chirayinkeezh Grama Panchayat, for a single room shop

The Secretary, Chirayinkeezh Grama Panchayat has sought CRZ clearance for a single room shop constructed in front of the house of Shri. Muhammed Ummar, as a means of his livelihood. The construction is in the NDZ of CRZ -III area in the Panchayat. The matter was placed before the last KCZMA meeting held on 09.05.2011. KCZMA decided to defer the case for consideration after obtaining a field inspection report.

Accordingly, field inspection has been conducted. In the field inspection report it is stated that, the site lies between 200 & 500 m HTL of sea. The shop room is constructed close to the house. As per CRZ Notification, commercial buildings are neither permissible nor prohibited in CRZ area. This is a small shop room of 13.44 m² plinth area. There are numerous shops and larger commercial buildings in the area. This being a non-polluting commercial building, KCZMA may consider the proposal for clearance.

POINT FOR DECISION

Whether CRZ clearance may be given to the single - room shop in front of the house, constructed as a means of livelihood, considering its small size (13.44 m² plinth area) and non-polluting nature.

CRZ clearance for a house constructed in the Panayam Grama Panchayat.

The Secretary, Panayam Grama Pancyayat has submitted a proposal for CRZ clearance for a house constructed in the Panchayat. The site is only 78 m landward from the Ashtamudi backwater. As per the Panchayat Secretary, the proposed construction by the applicant, Sri. Ajith Kumar is in the ancestral property and he has no other property elsewhere. The Environment group of KSCSTE after examining the proposal has stated that the construction is in the NDZ of CRZ III. The matter was placed before the KCZMA meeting held on 09.05.2011 and the decision was to defer the case for consideration after obtaining a field inspection report.

In the field inspection report, it is stated that the construction is made 78m from the Kayal, which has more than 100m width. The CRZ will be 100m landward of HTL. The construction seems regularised, since during the inspection, the owner has informed that his building was allotted number during an Adalat. As per the provisions of CRZ Notification, the construction is violation of provisions in CRZ Notification. A suitable decision may be taken, as it is a small residential building.

POINT FOR DECISION

Whether CRZ clearance may be given to the residential building constructed.

Request for change of CRZ Status of Edava Grama Panchayat

Edava Grama Panchayat is currently put in CRZ III category. Considering the development status of the area, the panchayat has requested to include it in CRZ II category. According to the environment group, Edava Grama Panchayat is not a legally designated local body or urban area. Hence, reclassification is not possible under the provisions of CRZ Notification 2011. The matter is placed before the KCZMA for suitable decision.

POINT FOR DECISION

Whether the request of Edava Grama Panchayat to reclassify its CRZ status may be agreed to.

Construction of Petrol pump and office building in Re-Sy.No.145/15,20 in Feroke Grama Panchayat, Kozhikode

The Secretary, Feroke Grama panchayat has informed that CTP has granted permission for the construction of a petrol pump and office building by BPCL on lease basis. The proposal was examined by KCZMA in its 34th meeting and rejected the same on the ground that commercial ventures are not permissible in CRZ area under CRZ Notification 1991.

Now the Secretary, Feroke Grama Panchayat submitted the revised plan for consideration. It is proposed to construct an office building of plinth area 39m² and canopy for petrol pump.

On consultation the Environment group opined as follows:

"The proposed construction of office building for the petrol pump in Feroke Grama Panchayat falls in the No Development Zone of CRZ III as it lies within 100m from High Tide Line of the river, which has tidal influence. Construction of office building and part of petrol pump lie in the CRZ. Receipt and storage of petroleum product is permitted in the No Development Zone of CRZ III while the petorl pump is not mentioned in the CRZ notification."

KCZMA may discuss and take a suitable decision.

POINT FOR DECISION

Whether CRZ clearance may be granted for the proposal.

GCDA-Ring Road Project Phase-1

The proposal for the construction of a ring road project by GCDA has been discussed in the 45th meeting of KCZMA and it was decided to direct GCDA to make a detailed presentation in the next meeting.

The proposed road starts from Cochin Marine Drive North end and ends at Kumbalam in NH-47. The alignment passes through CRZ-I, CRZ-II, CRZ-III & CRZ IV areas. Reclammation of area in CRZ IV category also involves in the project. But this activity is prohibited in CRZ area. Certain commercial activities including construction of offices of Port Trust, development of park, public recreation space, and for leasing of land for development are proposed in the project.

Construction of road is permissible except in CRZ 1(1) but other activities are not permissible.

Hence, the Authority decided to get more information from the applicant for which the presentation has been called for.

Point for decision

KCZMA may decide on the basis of the presentation made by the project proponent.

From the report of the District Collector, it is clear that CRZ rules, and Paddy field and Wetland conservation Act were violated in the instant case. It is also reported that large extent of mangroves were destroyed and construction work was started at the site.

KCZMA discussed the case and decided to initiate action as per section 5 of E.P. Act and Rule 4 of E.P. Rules and to issue notice to the proponent and the Pappinissery Panchayat.

They have proposed for improving secondary drains and inlets to Elathur-Kallai (EK Canal) and construction of drainage outlet to sea. As per CRZ Notifiction 2011, construction of drainage is permissible in CRZ area including CRZ-I.

KCZMA discussed the case and decided to grant CRZ clearance for the project.

Judgment dated 07.02.2011 in W.P(C) No.3823/11-reg.

As per the Judgment dated 07.02.2011 in W. P(c) No. 3823/11 filed by one Sri.Danesh Kumar, Kannur, the Hon'ble High Court has directed the Chairman, KCZMA to consider the application of the Petitioner, after conducting necessary enquiry. A site inspection was conducted. The site inspection revealed that the area comes in the NDZ of CRZ-III. It is not a legally designated urban area to be categorised as CRZ – II. (1).

Preparation of DPR for the Pilot Project at Mathipuram slum in Vizhinjam, Thiruvanathapuram under the Rajiv Awaz Yojana.

The Thiruvananthapuram Corporation has decided to take Mathipuram slum as the pilot project under Rajiv Awaaz Yojana (RAY), which is a Central Government, sponsored slum Eradiction Scheme. 1200 houses are to be constructed for the project. In CRZ, two floors (G+1) with a height of 9m is permitted. But the Corporation has proposed three-floor (G+2) structure for the reason that 1200 houses are to be constructed with a carpet area of minimum 25m² each and area of the land is limited.
