Sub: KCZMA – Condonation of delay of applications submitted for CRZ Clearance for the constructed residential buildings– Delegation of power to the District Level Committees- Orders issued

### **ORDER**

As per order read as 3rd paper above, Kerala Coastal Zone Management Authority had delegated the power to all District Level Committees of KCZMA to treat the applications submitted up to 08.11.2021 for CRZ Clearance of already constructed residential buildings that are otherwise permissible as per the prevailing CRZ Notification, without obtaining prior clearance as late application and also to condone the delay occurred in such applications based on the merits of the case.

Later, several applications for CRZ Clearance for the residential buildings constructed after 08.11.2021 are being received in KCZMA. The 123<sup>rd</sup> meeting of KCZMA held on 29.6.2022 discussed the matter in detail and decided to direct all District Level Committees of KCZMA to treat the applications of constructed residential buildings received up to 29-06-2022, that are otherwise permissible as per the CRZ Notification 2011 as late applications and also to condone the delay based on the merits of the case. While condoning the delay, the list of CRZ violations reported by the District Coastal Committees shall also be verified. No further extension of time will be given in this regard and structures constructed henceforth without prior clearance will be treated as illegal.

In the circumstances, Kerala Coastal Zone Management Authority hereby delegates the power to all the District Level Committees of KCZMA to treat the applications received up to 29-06-2022, of constructed residential buildings that are

otherwise permissible as per the CRZ Notification 2011, as late applications and also to condone the delay based on the merits of the case. While condoning the delay, the list of CRZ violations reported by the District Coastal Committees shall also be verified. Scrutiny fee shall be collected as per the GO (Ms) No. 01/2015/S&TD dated 25/03/2015. No further extension of time will be given in this regard and structures constructed henceforth without prior clearance will be treated as illegal.

The District Level Committee's meetings that consider the late applications shall strictly be presided over by the District Collector concerned and the **POWER SHALL NOT BE DELEGATED** to any other officer for the purpose.

DLC meeting not chaired by the District Collector shall be deemed invalid.
